SuperCom's solutions are deployed across a range of use cases, including house arrest, GPS-based location monitoring, domestic violence prevention programs, alcohol monitoring, and rehabilitation-focused supervision. These programs are designed to help governments manage offender populations while maintaining oversight, accountability, and compliance with legal requirements.

The company operates through an integrated platform that combines wearable monitoring devices, home-based equipment, cloud software, and ongoing services. SuperCom serves government customers across North America and EMEA and has supported monitoring programs for more than 100,000 individuals worldwide through long-term public-sector contracts.

- **Growing Market Demand:** Structural pressures on criminal justice systems, including high recidivism rates, prison overcrowding, and rising incarceration costs, continue to drive government adoption of electronic monitoring solutions.

SuperCom focuses on providing electronic monitoring solutions that support government supervision programs within criminal justice, corrections, and public safety systems. The company's technology enables authorities to monitor individuals both within correctional facilities and in community-based settings under court-ordered conditions.

Electronic monitoring programs address structural challenges faced by justice systems, including high recidivism rates, prison overcrowding, and rising incarceration costs. Governments increasingly rely on monitoring alternatives to manage lower-risk populations while preserving correctional capacity for higher-risk cases.

SuperCom delivers its solutions through an integrated platform that combines wearable monitoring devices, home-based equipment, cloud-based software, and ongoing services. These systems collect location and compliance data in real time, allowing authorities to confirm adherence to supervision requirements and respond promptly when violations occur.

The company serves government customers across North America and EMEA and has operated monitoring programs for more than 100,000 individuals worldwide. Since 2014, SuperCom has been awarded more than 15 national-level electronic monitoring projects, reflecting its experience operating large-scale, multi-program deployments.

SuperCom generates revenue through long-term government contracts that typically span five to fifteen years. This structure supports recurring revenue tied to enrollment levels rather than one-time equipment sales. With established government relationships, an integrated technology platform, and expanding deployments in both the United States and international markets, the company continues to build scale within the global electronic monitoring sector.
